Chicago 36th Ward Alderman Gilbert Villegas Named Honorary Chief by IFA



Though he faced an uphill battle, because of his unwavering support and determination, Alderman Villegas successfully passed an ordinance in February to require 10 year smoke detectors in Chicago dwellings, so the requirement is consistent statewide. Back in 2017 when the 10 Year Smoke Detector ordinance was passed in Springfield the City of Chicago insisted they be exempted but Alderman Villegas worked to change that. On July 28th IFA Lobbyist Margaret Vaughn presented Alderman Villegas with am honorary chief's helmet with his name on it from IFA in appreciation for his dedication to the fire service.

LEGISLATIVE UPDATE

EMS OSHA RESPIRATOR QUESTIONNAIRE BILL SIGNED by GOVERNOR

SB 121 sponsored by Sen Neil Anderson (R-Moline) on behalf of IFA, which will allow EMS professionals to complete OSHA respirator questionnaires for fire service personnel was signed by the Governor on July 9th and will go into effect January 1st. After being able to complete the questionnaires for decades, the Illinois Department of Public Health decided 2 years ago that only doctors could sign them, which would put not only a financial strain on fire departments but created a hardship in medically under served areas in which doctors are in short supply. The Department of Public Health

removed their opposition to the bill, which now clarifies under the Emergency Medical Services Act that EMT, EMT-I, A-EMT, Paramedic or PHRN as permitted by their EMS System Medical Director. Special thanks to Sen Anderson and our House sponsors Rep. Dan Swanson (R-Woodhull), Kathleen Willis (D-Addison), Mike Halpin (D-Rock Island) and Tom Morrison (R-Palatine).

FIRE SERVICE RELATED BILLS SIGNED by GOVERNOR

HB 51- Chicago Smoke Detectors Compliments Alderman Villegas ordinance by amending state Smoke Detector Act to include Chicago in 10 year smoke detector requirement. House Sponsors Rep. Jaime M. Andrade, Jr. Senate Sponsors Sen. Cristina H. Pacione-Zayas and Craig Wilcox Signed into law and effective July 9

HB 351- Injury Reports to Dept of Insurance Amends the Downstate Firefighter Article of the Illinois Pension Code. Requires the fire chief of a secondary employer to report any injury, illness, or exposure incurred by a secondary employee during his or her employment to the Department of Insurance. Requires secondary employers to transmit to the Department of Insurance a certified copy of its report accounting for all hours worked by secondary employees. House Sponsors Rep. Lance Yednock. Senate Sponsors (Sen. Melinda Bush and Karina Villa-Christopher Belt-Robert F. Martwick) Signed into law and effective July 9th

HB 640 - Additional Members to FAC Adds the Illinois Chapter of the International Association of Arson Investigators and the Mutual Aid Box Alarm System (MABAS) Illinois in the organizations from which ex officio members of the Illinois Fire Advisory Commission shall serve. House Sponsors Rep. Kathleen Willis-Daniel Swanson and Tony McCombie. Senate Sponsors Sen. Cristina Castro Signed into law and effective August 8th

HB 809 – **JLMC-FIREFIGHTER APPOINTMENTS** Amends the Illinois Municipal Code and the Fire Protection District Act. In Sections relating to establishing a program for placing persons eligible for placement on a master register of candidates for full-time firefighter placement, provides that nothing in the listed Sections requires the Joint Labor and Management Committee to establish, or operate a community outreach program or master register of eligibles or to contract with a testing agency to establish or operate such program or register, unless the Committee chooses to do so. House Sponsors Rep. Jay Hoffman Senate Sponsor (Sen. Karina Villa) Signed into law and effective Jan 1st

HB 2860 FIRE CHIEF VEHICLE EQUIPMENT Amends the Illinois Vehicle Code. Provides that vehicle of deputy fire chiefs and assistant fire chiefs may be equipped with a siren, whistle, or bell capable of emitting sound audible under normal conditions from a distance of not less than 500 feet. Provides that deputy fire chiefs and assistant fire chiefs are eligible for fire chief license plates. Provides that any fire chief, deputy fire chief, or assistant fire chief operating warning devices upon a vehicle not owned by a municipality or fire protection district shall display fire chief license plates. Provides that, with the exception of permanently issued license plates, upon the resignation, termination, or reassignment to a rank other than fire chief, deputy fire chief, or assistant fire chief, a person issued fire chief license plates shall immediately surrender the license plate to the Secretary of State. Provides that the Secretary of State shall have the ability to recover the license plates. House Sponsors Rep. Daniel Swanson, Chris Miller, Mark Luft, Jeff Keicher, Mike Murphy, Mark Batinick, Thomas M. Bennett, Tony McCombie, Norine K. Hammond and Dan Ugaste Senate Sponsor Sen. Neil Anderson Signed into law Aug 20th and effective Jan 1st

HB 2864 – Volunteer EMS Credentialling Amends the Emergency Medical Services (EMS) Systems Act. Provides that, in a rural population of 5,000 or fewer inhabitants, each EMS System Medical Director may create an exception to the credentialing process to allow registered nurses, physician assistants, and advanced practice registered nurses to apply to serve as volunteers who perform the same work as EMTs. Requires that, as part of the volunteer recognition process, EMS Systems shall ensure that registered nurses, physician assistants, and advanced practice registered nurses have an active license issued by the Department of Financial and Professional Regulation. This system-level recognition shall require documentation and proof of the completion of at least 20 hours of prehospital care-specific coursework approved by the Department of Public Health and 8 hours of observant riding time. Provides that each EMS System Medical Director who creates an exception to the credentialing process may require additional training or documentation and may reject a volunteer applicant for just cause. Provides that each exemption period shall be no longer than one year, after which time a volunteer applicant may apply for another exemption. Provides that each EMS System Medical Director is responsible for ensuring that volunteer applicants meet EMS System requirements for credentialing and authorizing the practice in accordance with the EMS System

plan for basic life support. Provides that exceptions to the credentialing process are only allowable for volunteer EMS agencies in Illinois. House Sponsors Rep. Daniel Swanson, Chris Miller, Mark Luft, Michael T. Marron, Thomas M. Bennett, C.D. Davidsmeyer, Tony McCombie, Steven Reick, Amy Elik, Avery Bourne, Norine K. Hammond and Dave Severin Senate Sponsors (Sen. Neil Anderson-Chapin Rose) Signed into law Aug 20th – effective Jan 1st

HB 3763 - FPD Response Time Study Amends the Fire Protection District Act. Provides that, before a fire protection district may close a fire station or dissolve the district, a response-time study must be conducted that shows, at a minimum, estimated response times to the territory currently served by the fire station or district and estimated response times to that territory after closure of the fire station or district. Requires a response-time study before any territory may be involuntarily disconnected or consolidated with another fire protection district or municipal fire department. House Sponsors Rep. Daniel Swanson-Frances Ann Hurley, Chris Miller, Mark Luft, Amy Grant and Lawrence Walsh, Jr. Senate Sponsors (Sen. Neil Anderson-Linda Holmes) Signed into law August 24th – effective January 1st

SB 561 - Creates the PFAS Reduction Act. Provides that a person, local government, fire department, or State agency may not discharge or otherwise use for training or testing purposes a class B firefighting foam containing intentionally added PFAS. On and after January 1, 2022, prohibits the knowing manufacture, sale, offering for sale, distribution for sale, or distribution for use of a class B firefighting foam containing intentionally added PFAS. Provides specified notice and recall requirements for manufacturers. Contains a prohibition and exemption for the manufacture, sale, offering for sale, or distribution for sale of food packaging containing intentionally added PFAS. Requires manufacturers of class B firefighting foam containing PFAS to register with the Environmental Protection Agency and pay to the Agency an annual registration fee of \$5,000. Requires the Agency to administer and enforce the Act and to adopt rules. Requires the Office of the State Fire Marshal to conduct a survey of fire departments and to provide a report of the results of the survey to the General Assembly no later than 90 days after its completion. Provides a civil penalty of \$5,000 for the first violation of the Act and \$10,000 for each subsequent violation. Provides that civil penalties collected must be deposited into the Environmental Protection Trust Fund to be used in accordance with the provisions of the Environmental Protection Trust Fund Act. Contains other provisions. Provides that any person who operates a refinery or chemical or ethanol plant, a storage and distribution facility, or a tank farm or terminal for flammable liquids, or who has a fixed foam system in use at a manufacturing facility or warehouse, may extend the date of compliance under specified provisions to January 1, 2027 if, prior to January 1, 2025, the person determines that additional time for compliance is needed and sends notice of the determination to the Office of the State Fire Marshal. Senate Sponsors Sen. Laura Ellman-Melinda Bush, Suzy Glowiak Hilton-Jacqueline Y. Collins and Laura M. Murphy House Sponsors (Rep. Anna Moeller) Signed into law and effective Aug 6th

SB 1714 –Removes Labor History Training Requirement. Amends the Illinois Fire Protection Training Act. Deletes provision that fire fighter training schools must provide training in the history of the fire service labor movement using curriculum and instructors provided by a statewide organization representing professional union firefighters in Illinois. Senate Sponsors Sen. Cristina Castro House Sponsor (Rep. Daniel Swanson) Signed into law August 6th and effective January 1st

FALL PRESS CONFERENCES for 10 YEAR SMOKE DETECTOR LAW

Thanks to a grant from First Alert, I have been working with the Illinois Fire Safety Alliance on continued public outreach and education on Illinois 10 Year Smoke Detector law set to go into effect January 1, 2023. This fall 8 Fire Departments in various parts of the state, were selected to receive 8 installation kits and 100 of the 10 year model smoke detectors. Press conferences are then held at each department.

The two press conference were held Aug 26th at the Chicago Heights Fire Department and on September 2nd at the Normal Fire Department. The rest of the press conferences for the fall are in listed below and we are in the process of scheduling on in St. Charles for November.

HANDS-ON COURSES:

12 HOURS EACH | FRIDAY, 1-5PM & SATURDAY, 8AM-5PM FOUNDATIONS OF FIREFIGHTING

The Foundations of Firefighting Course was developed for new firefighters. The class is designed to safely place you on the working fire grounds. The course will cover the usage of self-contained breathing apparatus (SCBA), line advancement, ventilation and basic fire ground operations. Material covered will result in your safety as an elective firefighter for your department.

NFPA compliant personal protective equipment and SCBA is required.

ESSENTIAL SKILLS FOR FIREFIGHTING

The Essential Skills for Firefighting Course incorporates multiple training topics into one convenient schedule. Class topics include forcible entry, RIT training and thermal imaging camera applications. Students will participate in hands- on drills with both inward and outward swinging doors as well as multiple types of tools and locks. Live fire scenarios will address the tactical and strategic operations related to downed firefighters and the operation of the thermal imaging camera.

NFPA compliant personal protective equipment, SCBA, and ear protection is required.

AGRICULTURE RESCUETECHNIQUES

The Agriculture Rescue Techniques Course will teach first responders and rescue personnel the principles and guidelines for safe response to agriculture related incidents. Subject matter covered includes tractor rollovers, grain auger entrapments, farm machinery entrapments, emergencies related electrical malfunctions, and chemical exposure incidents. Confined space and how it relates to incidents that involve manure pits and grain bins will be covered as well. Students will learn extraction methods, machinery stabilization, lock out/tag out of hazardous systems, patient assessment, and packaging.

Turn out gear or coveralls, helmet, gloves, eye and ear protection, and steel toed shoes are required.

THERMAL IMAGING CAMERA: APPLICATION FOR SEARCH AND RIT OPERATIONS

The Thermal Imaging Camera: Applications for Search and RIT Operations Course provides in-depth training on the use of thermal imaging cameras on response scenes. Class topics include basic camera function, search techniques, fire behavior, and RIT operations. Students will engage in multiple live fire training scenarios that will connect the usage of the fireground tool to primary and secondary search techniques, RIT operations, and victim removal using webbing. This course will challenge all skill levels.

CLASSROOM COURSES:

4 HOURS EACH | Instructedby NVFCInstructors

LEADERSHIP FOR THE FIRE AND EMERGENCY SERVICES FRIDAY, 1-5PM

Quality leadership is essential for the fire and emergency services to accomplish the mission and improve your department. This course examines leadership styles, qualities, ethics, and best practices to help your department function at a high level and avoid fire and emergency services leadership pitfalls. New retention research will also be discussed to help leaders understand retention concerns and identify solutions.

RECRUITMENT AND RETENTION FOR EMERGENCY SERVICES SATURDAY, 8AM-12PM

Many fire and EMS departments across the nation are struggling to find new volunteer members and retain their current members. This session discusses the challenges of recruiting volunteers, presents valuable research collected as part of the NVFC's Make Me A Firefighter campaign, and ollers ideas to help overcome recruiting challenges. During the second half of the session, retention challenges, potential solutions, and the importance of leadership will be covered.

VOLUNTEER FIRE SERVICE CULTURE: ESSENTIAL STRATEGIES FOR SUCCESS SATURDAY. 1-5 PM

The NVFC published the textbook Volunteer Fire Service Culture – Essential Strategies for Success as a guide to fire service leaders who desire to change their department's culture and attitude towards personal health and safety. This training delves into key points from the guide to reinforce the need for change and provide a roadmap for implementation of change to improve the health and safety of volunteer fire and EMS responders.

FRIDAY EVENING ACTIVITIES, 7-9PM:

MYTHS & REALITIES: FOG NOZZLE VS. SMOOTH BORE NOZZLE

(LIMITEDTO 30 STUDENTS)

The Myths and Realities: Fog Nozzle vs Smooth Bore Nozzle class will focus on one of the most historic debates in the fire service. Instructors will address the use of the fog nozzle or the smooth bore nozzle during fire attack, the benefits of specific usage, and safety measure comparisons. The course will explore different hose stream selection for the fire attack and the pros and cons of each choice.

ADVANCED AND COMMERCIAL FORCIBLE ENTRY

(LIMITEDTO 15 STUDENTS)





Appellate Court Rules Firefighter Forced to Retire at Age 65 Is Ineligible for Unemployment Benefits

By law, full-time firefighters in Illinois must retire at age 65. Sometimes, this separation is less-than-voluntary, which prompts the question of whether such firefighters are entitled to unemployment benefits. Recently, the Illinois Appellate Court ruled firefighters who are required to retire upon reaching age the statutorily mandated retirement age of 65 are not eligible for unemployment benefits under the Illinois Unemployment Insurance Act ("Unemployment Act").

In *Prospect Heights Fire Protection District v. Department of Employment Security*, firefighter Robert Pyzyna was employed by the Prospect Heights Fire Protection District from June 2005 until he retired in October 2017. 2021 IL App (1st) 182525. His retirement "was predicated on his reaching the age of 65, the mandatory retirement age for active firefighters" set by statute. Upon retirement, Pyzyna began receiving pension benefits from the District's firefighters' pension fund.

Nevertheless, Pyzyna also filed a claim for unemployment benefits under the Unemployment Act claiming that he had been "laid off" from his employment with the District.

The Unemployment Act provides unemployment benefits to individuals who become unemployed through no fault of their own. However, an individual will become ineligible for unemployment benefits for the period "in which he or she has left work voluntarily without good cause attributable" to the employer or for misconduct connected with his or her job.

The District challenged Pyzyna's claim and argued he was not eligible for unemployment benefits because he had *not* been laid off. In fact, he was receiving retirement pension benefits.

The Illinois Department of Employment Security ("IDES") ruled in favor of Pyzyna and concluded that his "separation from the District was neither voluntary nor the result of misconduct." Indeed, IDES found that Pyzyna did not voluntarily leave his employment with the District—the District caused Pyzyna's unemployment when it required him to retire upon reaching age 65. IDES also noted that the District had failed to introduce any evidence that Pyzyna had engaged in misconduct that would make him ineligible for benefits. Because there was no evidence that Pyzyna left his job voluntarily or that he was discharged for misconduct, IDES thus found him eligible for unemployment benefits.

The District appealed IDES's ruling to the circuit court, which overturned the decision. In the circuit court's view, Pyzyna had voluntarily agreed to the "statutorily prescribed mandatory retirement age" of 65 when he accepted his employment with the District. This made Pyzyna ineligible for unemployment benefits.

The appellate court agreed. It held that "an Illinois firefighter who leaves his or her employment upon reaching the mandatory retirement age of 65 does so voluntarily absent good cause attributable to the employer and is not eligible to seek unemployment benefits" under the Unemployment Act. The mandatory retirement provision at issue was not set by the District but was required by statute and is applicable to fire departments and firefighters. Therefore, "Pyzyna and all other firefighters thus know that their careers as firefighters are finite and will terminate when they reach mandatory retirement age of 65." Upon accepting employment with the District, Pyzyna "accepted and agreed to abide" by this mandatory retirement requirement. Since Pyzyna left his employment with the District "in accordance with the terms of his employment that he accepted when he commenced his career as a firefighter, he did so voluntarily." And since "the mandatory retirement policy at issue was set by statute and not by the District, Pyzyna's separation from his place of employ cannot be considered good cause attributable" to the District.

The decision in *Prospect Heights* makes clear that statutorily mandated retirements are considered "voluntary" and, thus, retirees are not eligible for unemployment benefits. Importantly, the decision did not address part-time firefighters who are not hired under the board of fire commissioners' provisions of the Fire Protection District Act or the Illinois Municipal Code that contain the mandatory retirement age requirement. Although it stands to reason that part-time firefighters should be subject to the same mandatory retirement requirements applicable to full-time firefighters, the law is not clear on this issue. It is also uncertain whether the logic of *Prospect Heights* would apply where a fire protection district or municipality affirmatively adopts a mandatory retirement age *under* 65. In these situations, fire protection districts and municipalities should ensure their mandatory retirement age policies are acknowledged by all firefighters at the time of hire.

The first time I saw how a fire sprinkler worked, I was a little upset ...





This two-day course is designed to help fire and emergency services learn what community risk reduction is and how to build organizational support for it.

This course includes three units of instruction:

- Unit 1: Components of Community Risk Reduction.
- Unit 2: Community Risk Reduction as a Service Priority.
- Unit 3: Building Organizational Support for Community Risk Reduction.

There is a pre-course assignment to complete before class that should take about one hour to complete.

Throughout the week leading to September 11th, we were bombarded with all the images and video clips we've lived with for 20 years. We vowed we would never forget.

We will never forget.

We keep the stories of the 343 firefighters close to our thoughts and hearts because their lives deserve it. Our firehouses have helmet fronts, banners, and posters adoring our training rooms and public spaces. We have tattooed "343" on our arms and "FDNY" on our backs. Some have made the trip to see the memorials in Manhattan, Shanksville, or the Pentagon. Our apparatus may bear the image of

the twin towers near the cab or the tailboard so that we, and everyone we serve, can see that the fire service stands together.

We will never forget.

We cannot forget because that day and the seemingly endless, arduous months of recovery that followed, have become part of our psyche. Like the dust that would not settle, the faces of the women and men of the fire service, the rescue efforts, and the debris cover our minds and cause our still grieving hearts to beat harder when we relive those days. And pray for the survivors. And feel every emotion that passes across our bodies.

Because vowing to never forget means feeling all that haunts us and inspires us. September 11th is a day in our lives when our passion to serve that stretches from big city departments to rural districts was brought together at the base of the towers. Twenty years later, we still find ourselves standing there.

These were our sisters and brothers who did what we all do wherever we serve: they heard the tone, grabbed their gear, climbed into their seats, and donned their packs. They carried hose lines and irons and carefully escorted thousands down stairwells to safety while simultaneously ascending. The coordination of duties was incredible and from command to rookie, they did their jobs without fail and without fulling knowing.

We will never forget.

Which means we will get angry. We will feel guilt wondering why we survived when others did not. We will wrestle old demons and we will shed tears. We may relapse. All of this is part of remembering, and proof that the 343 and the thousands who died are woven to our lives. I encourage you, friends: do not deal with your distress alone. Talk to someone, whether a chaplain, peer support, or a counselor, because you are not alone.

We will also feel pride that we have the privilege of telling the stories from the perspective of the ones who can no longer tell it themselves. We will feel inspired each time we don our gear, climb into a seat, and answer the call. We will trust our training and lean on the solidarity of the countless firefighters and medics who respond alongside us across the country. We will continue to have hope. Because we will never forget.

As we carry on for those who have earned their rest, I offer this prayer from Father Mychal Judge, FDNY chaplain, whose death continues to haunt me with sadness and hope. "Lord, take me where you want me to go. Let me meet who you want me to meet. Tell me what you want me to say. And keep me out of your way."

Take care of yourself, take care of your company, watch out for each other.




