HISTORICAL DATA

Lincoln, Illinois, September 27, 1888

On invitation of Chief Thomas L. Blackburn, of Lincoln, a tournament was held with the following department present: Mt. Pulaski, J. Hopkins, chief; Mattoon, George Redfern, chief; Peru, J.W. Henshaw, chief; Lincoln, Tomas L. Blackburn, chief; Clinton, J.E. Moffet, chief; Effingham, Henry Vogt, chief; Delevan, C.W. Few, chief; Champaign, Walter E. Price, chief. At the close of the tournament a meeting was held and it was agreed to notify the Firemen of Illinois is meet at Clinton on January 8, 1889, for the purpose of organizing the Illinois Firemen's Association. The delegates from the various fire departments of the state met as agreed at Clinton, Illinois, on January 8, 1889, and adopted a Constitution and By-Laws. The Accident Indemnity Plan was adopted at this meeting, on a basis of assessments of five cents for each member of the departments in cities and villages of less than 30,000 population. Benefits, \$1.00 per day for injuries received "While going to, at or returning from a fire," causing at least seven days disability. Optional with the departments as to being placed on the protected list.
